MAHMA shall have the right to consider this contract terminated and to retain as liquidation damages all monies paid to days prior to the event that it will be unable to exhibit, exhibitor may be refunded all monies paid, less \$150 per space, which shall be retained by MAHMA as liquidation damages. MAHMA reserves the right to cancel this contract should exhibitor disregard any rules or regulations of the show or for other due cause. In the event MAHMA shall enforce such right, all monies paid by exhibitor shall be retained by MAHMA as liquidation damages.

Exhibitor assumes entire responsibility and hereby agrees to protect, identify, defend and hold Embassy Suites, Indianapolis North and its employees and agents harmless against all claims, losses and damages to persons or property, governmental charges or exhibition premises or a part thereof, excluding any such liability caused by the sole negligence of the Embassy Suites, Indianapolis North and its employees and agents.

In addition, exhibitor acknowledges that Embassy Suites, Indianapolis North does not maintain insurance covering the exhibitor's property and that it is the sole responsibility of the exhibitor to obtain business interruption and property damage insurance covering such losses by the exhibitor.
